

New Single Family Fee Schedule

Below you will find the most common fees associated with new single family construction. This is to be used as a guide only and fees may change based on the scope of your project. This schedule is based on a new single family house being constructed on a vacant lot in the City of Issaquah's water service area. If the lot is located in another water district or the lot is not vacant, different fees will apply. Review your plat requirements for any additional charges. At time of permit application, a \$1,000 plan review deposit is required. The deposit will be credited toward your *Plan Review Fee* at time of permit approval. All fees listed are per house.

Fee	How It's Calculated
Building Permit Fee	Based on Project Valuation Chart
Plan Review Fee	65% of <i>Building Permit Fee</i>
Consultant Fee	If consultant review is requested, 50% of <i>Building Permit Fee</i> . Additional hourly and shipping fees may apply. This is an additional line item and does not replace the above <i>Plan Review Fee</i> .
Mechanical Permit Fee	Based on number of fixtures see Mechanical Permit Fee Schedule (Do not include plan review or technology surcharge)
Plumbing Permit Fee	Based on number of fixtures see Plumbing Permit Fee Schedule (Do not include plan review or technology surcharge)
Digital Fee¹	Based on number of pages in plan set. See Digital Fee Schedule .
Technology Surcharge	5% of everything above this line
State Surcharge	\$4.50 (add \$2 for each additional dwelling unit)

King County Sewer Capacity Charge

Every new sewer connection will be assessed a Sewer Capacity Charge by King County. The total cost is based on the date of the sewer connection. This fee is administered by King County and is not included in any of the fees listed on page 1 of this document.

Additional Permits

This schedule does not include additional permits that may be required. The most common additional permits are:

Permit	Note
Backflow Device for irrigation system	This is a separate permit issued over the counter. See the Plumbing Permit Fee Schedule
Fire Sprinkler	See Fire Permit Fee Schedule
Electrical Permit(s)	These are issued and inspected by Washington State LNI
